Job Title: SEL/Mental Health Clinician (2019-2020 School Year)

Program: School Based Counseling Services

JOB REQUIREMENTS

1. Provide outpatient mental health support to diverse population of students in San Mateo County schools, including group and individual psychotherapy, assessment, treatment planning, crisis intervention, and mental health consultation.
2. Provide classroom-based lessons on Social-Emotional Learning (SEL) utilizing school-approved curriculum and materials.
3. Collaborate with school and agency staff to assist in coordination of ethically appropriate, culturally informed, and holistic interventions to address client issues and enhance client strengths.
4. Participate fully on the School-Based Services team, attending weekly team meetings, quarterly chart audit, and other trainings as required.
5. Maintain timely and clinically appropriate documentation of all services.

MINIMUM QUALIFICATIONS

A Master's or Doctorate degree in Social Work, Psychology, or Counseling from an accredited program). Registered or registration eligible with Board of Behavioral Sciences (BBS) or Board of Psychology (BOP) and licensed or license-eligible. One year of clinical experience, preferably working with children or youth.

SUCCESS FACTORS

1. Enjoy working with children, youth, and families utilizing a strengths-based perspective.
2. Familiarity with effective school-based interventions, including systems-based, solution-focused, experiential (play/art), and/or brief therapeutic modalities.
3. Ability to work as a member of a multidisciplinary team and collaborate with other providers at school site to ensure a high standard of care.
4. Working knowledge of trauma-informed practices and ability to provide consultations for colleagues, other providers, and/or school staff.

5. Experience with large group presentations, workshops, tutoring, or classroom teaching, and/or a background in education is strongly preferred.
6. Fluency in Spanish preferred (not required).

PROGRAM DESCRIPTION

StarVista's School Based Counseling Services provides high quality mental health services in more than 30 diverse schools throughout San Mateo County. These services include assessment, crisis intervention, individual and group therapy, as well as extensive consultation and training with teachers, parents, administration, and support staff. The goal of our services is to improve aspects of a child's life that lead to increased engagement in learning.

POSITION STATUS

Position is 21-36 hours/week, beginning August 19, 2019 (pending background clearance) and continuing through mid-June 2020. Part-time work hours may be available during summers. **Exact hours are negotiable, depending on applicant's availability.** Position is non-exempt; employee will be eligible for medical, dental, vision benefits. Employee will receive pro-rated PTO, including 13 paid holidays as well as personal, sick, and vacation time. Other benefits include staff wellness retreats and access to numerous free and CEU-eligible trainings.

Clinician will receive approximately 10-20 hours of direct clinical time eligible for licensing requirements and 3 hours a week of supervision. **Required availability during school hours (8:30am-4pm)** a minimum of 3 days per week.
