POSITION PURPOSE AND OBJECTIVES:

Oversee day to day operations of facility providing sobering, counseling and referral services, and respite to individuals arrested for alcohol and drug related offenses, referred by emergency departments, or referred by other partner agencies including law enforcement and the health system. Oversee day to day operations of the Outpatient clinic that provides clinical services to dually diagnosed individuals referred from AOD and the court system under Drug Medical. Perform assessment of substance abuse history and patterns to assist staff in treatment planning. Provide services as needed in program. Ensure the programs provide supportive, ethically appropriate, culturally informed services congruent with agency philosophy to clients. Oversee day to day operations of the Integrated Medication Assisted Treatment (IMAT) program in collaboration with San Mateo County General Hospital. Oversee day to day operations in expanding First Chance Sobering Station to include a 4 bed Detox Facility.

ESSENTIAL FUNCTIONS and RESPONSIBILITIES:

- 1. Responsible for smooth operation of daily program activities of First Chance.
- 2. Assure consistency of the program activities with agency vision and plan.
- 3. Conduct individual supervision with regular staff and monthly supervision with relief staff.
- 4. Attend meetings including: Alcohol and Drug Providers meetings; monthly Program Managers meetings; bi-weekly departmental meetings; weekly individual supervision with Department Director; Healthcare for the Homeless and Farmworkers, Human Trafficking Initiative, and quarterly police chief's meetings.
- 5. Provide regular information for FC staff from meetings above when appropriate. Coordinate and assure productive communication between STARVISTA management staff and other department and FC staff.
- 6. Compile agenda items and lead regularly scheduled staff meetings.
- 7. Coordinate staff recruitment and retention efforts with Department Director.

- 8. Review and ensure appropriateness of client admissions and services www.star-vista.org provided by counseling staff.
- 9. Review and respond to incident reports.
- 10. Provide consistent on call supervision of program. Communicate closely with the Dept. Director regarding crisis calls and incidents requiring management level response.
- 11. Provide counseling, individual and group, supervision, and other services as needed.
- 12. Provide back up on call coverage for scheduling issues.
- 13. Ensure appropriate and positive relationships with law enforcement and county agencies.
- 14. Conduct briefings/meetings with participating police departments; typically on a quarterly basis.
- 15. Train officers in the Police Academy about the utilization of First Chance when invited. provide other community training as needed.
- 16. Supervise ASW, MFT and LPC interns, and certified staff as needed and/or required.
- 17. Ensure timely submission of monthly, quarterly and annual statistics to StarVista and to participating entities of First Chance.
- 18. Provide and coordinate ongoing training for staff.
- 19. Oversee quality assurance with respect to documentation and record keeping of all staff. Ensure the maintenance of confidential records and case notes/progress notes documenting interventions and interactions with clients. Follow Drug Medical guidelines for compliance. Abide by all HIPAA regulations.
- 20. Responsible for cleanliness of the facility and reporting of facility maintenance needs to the STARVISTA facility representative and to the Dept. Director.
- 21. Assist with program development and marketing activities in conjunction with the Department Director and Executive Director.
- 22. Other duties as assigned.

KNOWLEDGE, SKILLS, AND ABILITIES REQUIRED:

- 1. Demonstrable and verifiable management skills and experience in providing successful supervisory oversight of treatment program activities.
- 2. Strong ethical principles reflected in practice, including a thorough understanding of client confidentiality requirements, including but not limited to HIPPA.
