StarVista's Archway program provides services for alcohol and drug treatment, anger management, and domestic violence intervention. Archway offers a variety of adult outpatient treatment services in both English and Spanish. **These include:**

Federal Program

The outpatient mental health and substance abuse treatment program is for adults in pre-trial and post-conviction services, serving all of San Mateo County. These clients do not have minimum treatment duration and can be in treatment for several years. Clients attend individual and weekly group sessions as well as other services as needed.

Adult Domestic Non-Violence Programs

- Domestic Violence: 52 weeks (104 hours) of group counseling, one time per week for two hours.
- Anger Management: 16 weeks (32 hours) of group counseling, one time per week for two hours.
- The maximum groups size for both programs is 12 participants of the same gender. Individual counseling is available and based on individual assessment.
- Both programs offer a sliding fee scale.

First Offender Drinking and Driving Programs

- The Wet and Reckless (W/R)
 Program is a court-mandated program that individuals attend after getting a first time arrest for driving under the influence with a Blood Alcohol Content (BAC) of .08% or less.
- The First Offender Program (FOP) 3-Months is a court-mandated program for individuals to attend after getting an arrest and conviction for Driving Under the Influence (DUI) of alcohol with a Blood Alcohol Content (BAC) of .09%-.19% or other drugs. This is for a first time offense.
- The First Offender Program (FOP)
 6 & 9-Month Program is a courtmandated for individuals to attend after getting an arrest and conviction for Driving Under the Influence (DUI) of alcohol with a Blood Alcohol Content (BAC) of .20% or above or other drugs. This is for a first time offense.

Deferred Entry of Judgment (DEJ) Program

 The Deferred Entry of Judgment (DEJ) Program and Proposition 35 Program are for individuals who receive an arrest and conviction for possession or bx*eing under the influence of illegal drugs. These programs are also now known as Criminal Justice Realignment (CJR) Services.

- The DEJ program is 8-16 weeks of group counseling sessions. Clients attend one group session per week for two hours. Clients attend 4-8 hours of individual counseling, which are 30 minutes or 1 hour long each. Clients attend a total of 16-20 Alcohol Anonymous (AA) and/or Narcotics Anonymous (NA) meetings and provide proof of completion.
- Random drug tests with acceptable dilution levels.

Outpatient Substance Abuse Services Treatment

The program requires a minimum of 3 months of treatment. Clients attend a weekly group session and complete individual counseling sessions. Clients are required to complete a minimum of six community support meetings.

Referral Process

 The program accepts referrals from service providers, schools, parents, and law enforcement agencies. Youth self-referrals are also encouraged.
